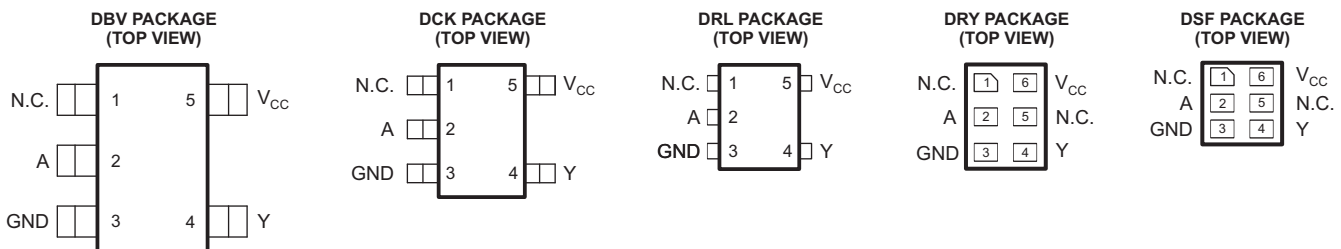

The SN74LVC1GU04 contains one inverter with an unbuffered output and performs the Boolean function  $Y = \bar{A}$ .

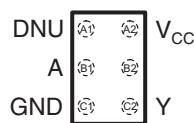

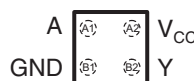

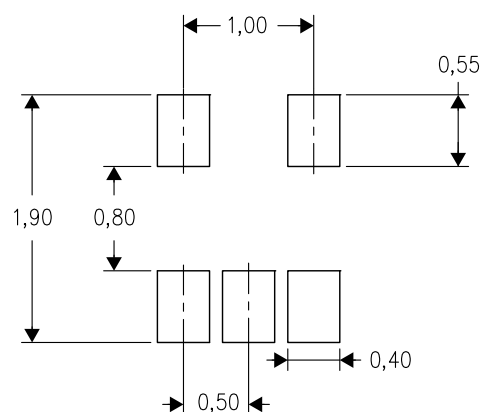

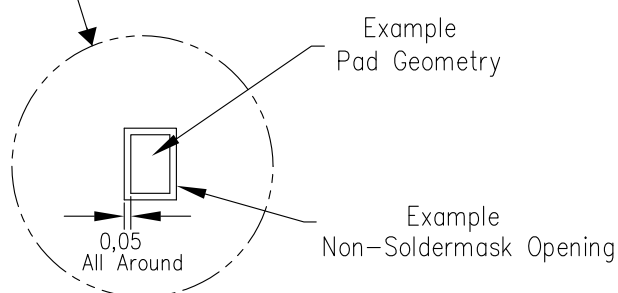
Example Board Layout

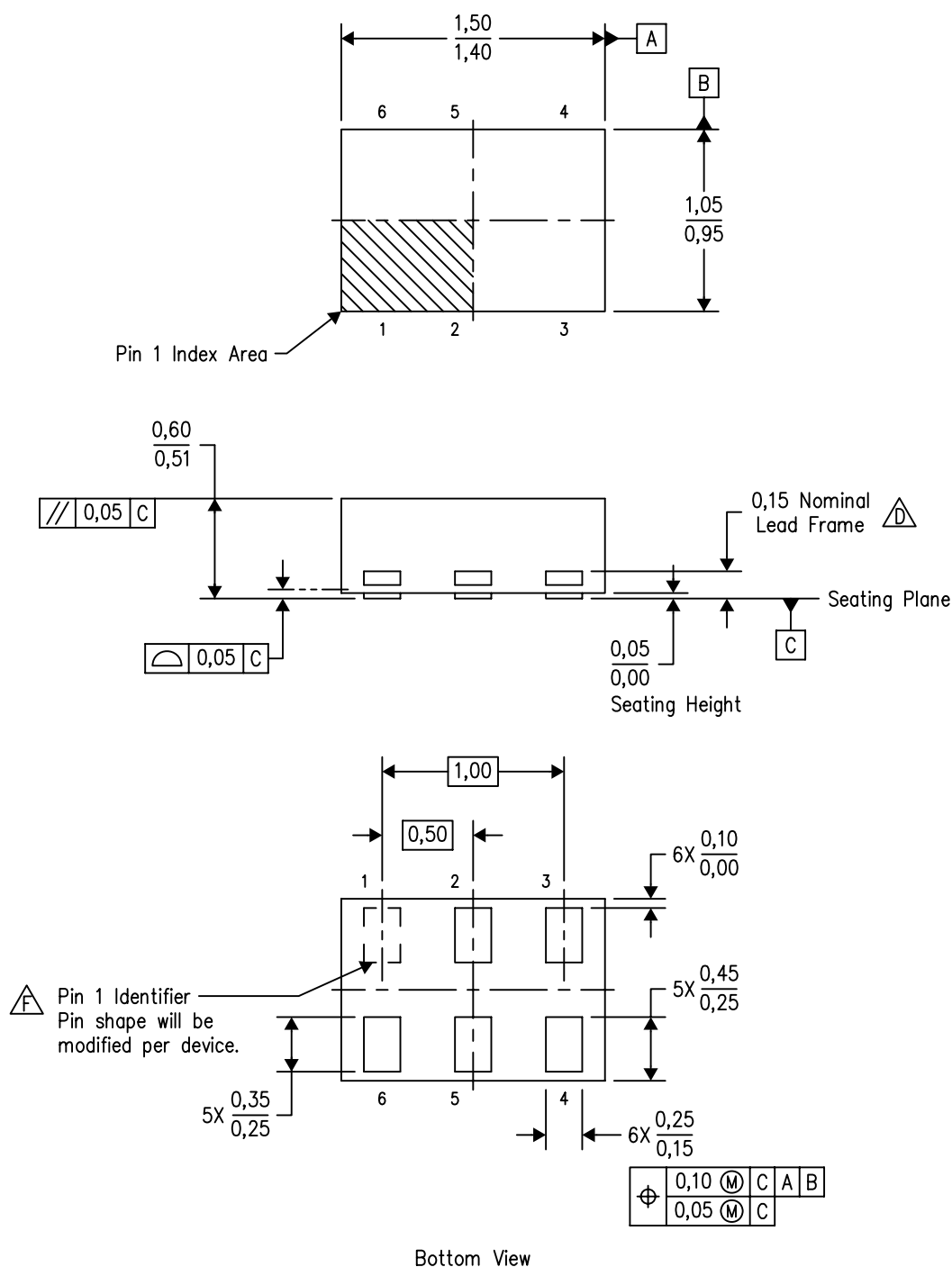

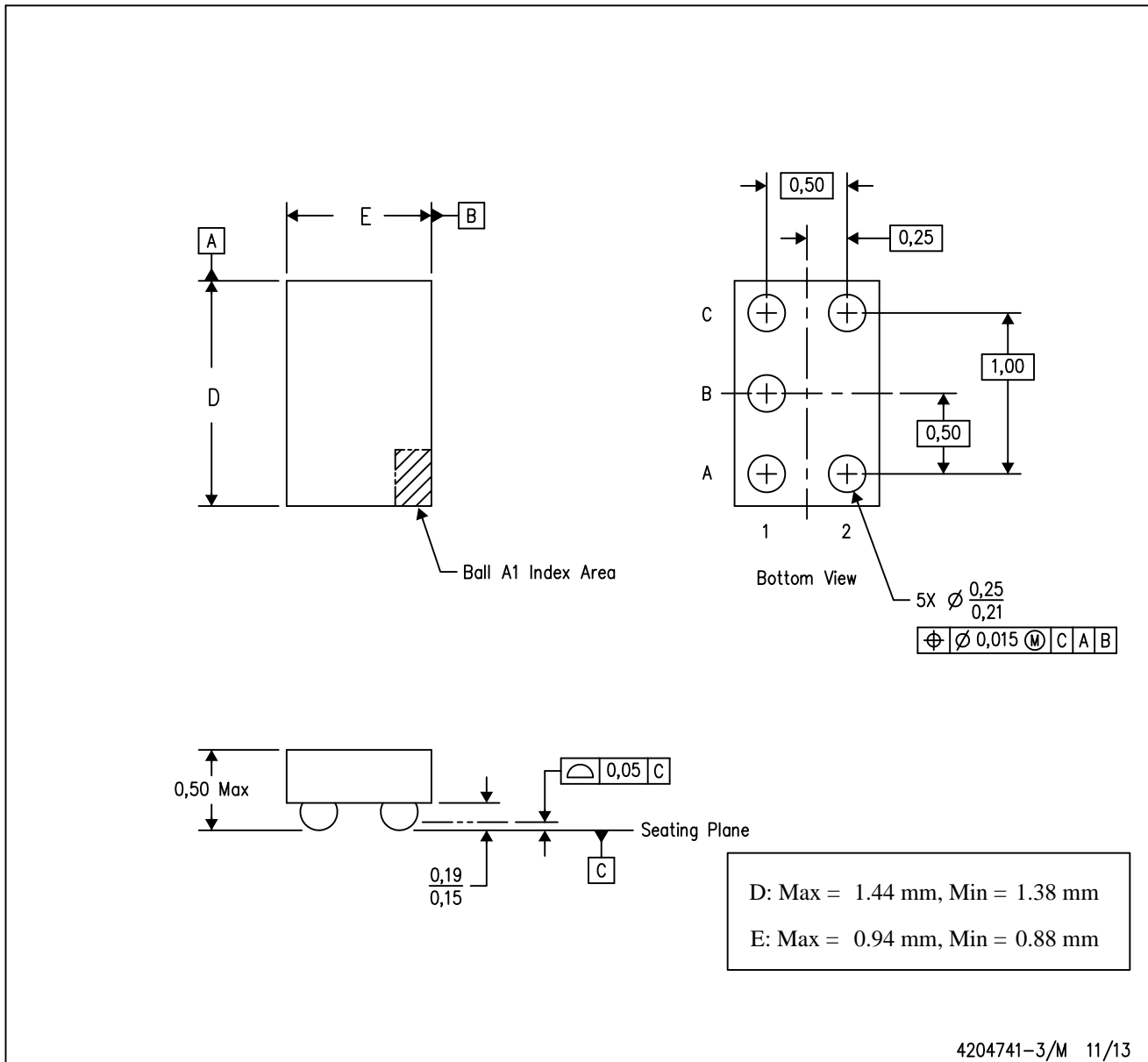

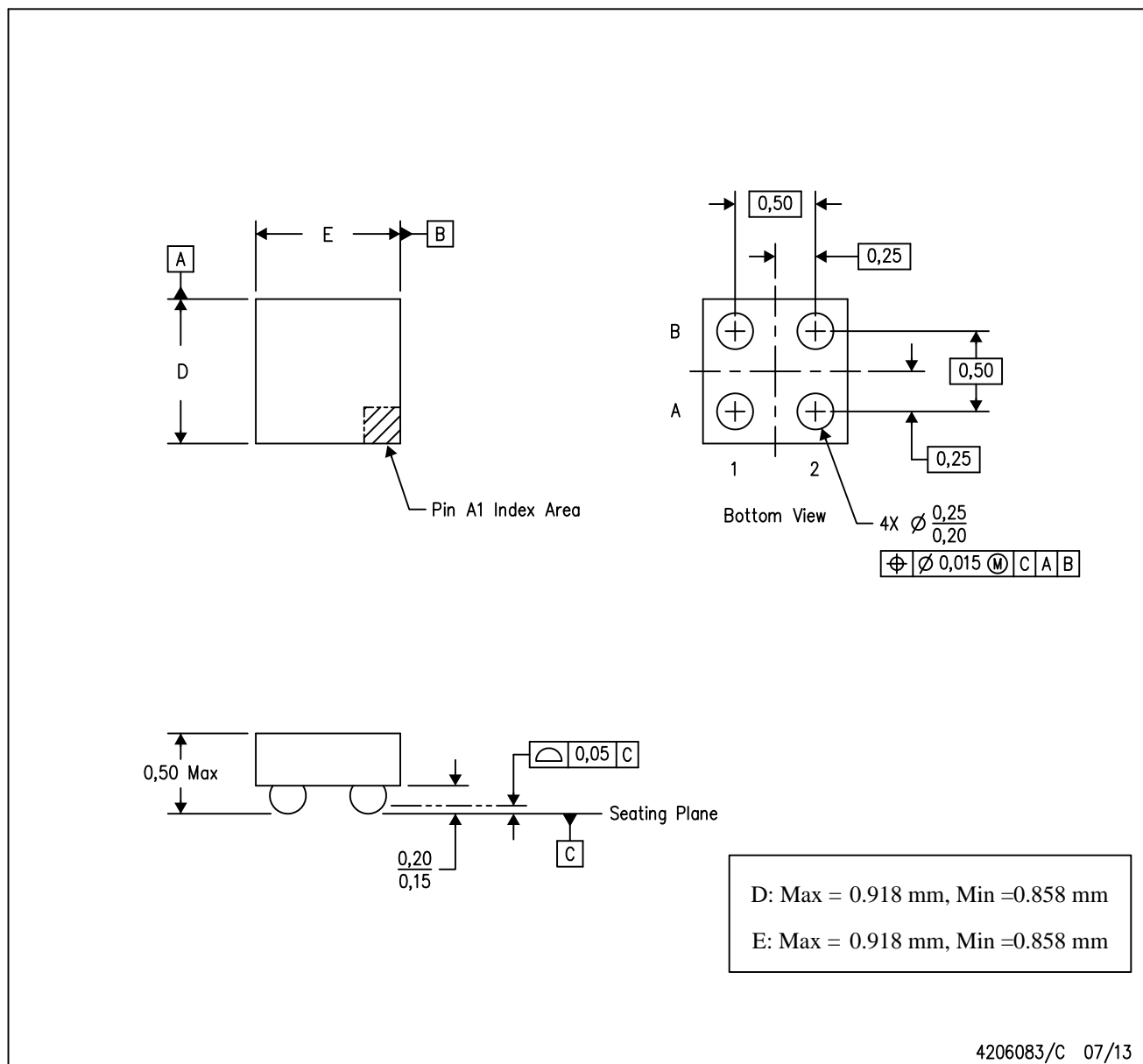
DIE-SIZE BALL GRID ARRAY
